## UPDATE ON LITIGATION IN RELATION TO A VERY SUBSTANTIAL ACQUISITION

On 29 February and 14 February 2012, Dr. Li Zhongyuan (Chairman of the Board of the Company) and Shanghai Weichang Investment and Management Consulting Co., Ltd (a subsidiary of the Company) were respectively served with a statement of claim by China Zhongfu, Shanghai Zhongfu, Anhui Anhe and Shanghai FSY against Mr. Li Zhong Yuan, Shanghai Weichang Investment and Management Consulting Co., Ltd, the Company and other 5 Defendants, in the Shanghai No. 1 Intermediate People's Court of the People's Republic of China seeking compensation for civil rights infringement allegedly based on a series of events arising from the Acquisition. The Company has received legal advice that it has not been properly served with a statement of claim at its registered address.

The claimants are seeking damages of RMB 45 Million and all the costs for this litigation collectively from the Defendants.

The Company is seeking legal advice and its intention at this time is to mount a full defence to these claims.
